## NE Tacoma Crime News

Www.tacomacrime.org shows numerous crimes during June and July, 2014: burglaries/breaking and entering, car thefts, thefts from vehicle (break-in), two assaults with a deadly weapon, simple assaults (likely domestic), and other thefts (likely from yards, etc). The site is useful for seeing what kinds of things are going on, but it tends to exaggerate some crime reports because of the simplicity of the description possibilities. For example, minor property theft often gets reported as a burglary, which we would usually associate with a house burglary with more major property theft.

## Stats from the Great Community Clean-Up Day on June 7<sup>th</sup>!

The numbers are a little lower than last year's record 422 participants:

- Number of attendees: 326 out of 5294 possible (6.15%)
- Number of containers hauled (generally these are 30 yard dumpsters): 28
- Tonnage (garbage and metal): 26.92 tons
- Refrigerators: 3, tires: 114
- Goodwill filled two trucks with re-usables

Some participants observed that they had cleaned out a lot of junk in the prior clean-up days, and had much less stuff to get rid of. We thank all who dropped their unwanted material off for helping to make NE Tacoma attractive and safe. We are following up on opportunities to have some facility for recycling at next year's event.

# Browns Point Lighthouse Park Improvements – Concept Plans

The Steering Committee supporting Metro Parks’ improvement planning work on Browns Point Lighthouse Park met on July 22<sup>nd</sup> to discuss the feedback from the June 30<sup>th</sup> public meeting and review Metro Parks’s concept plan. Discussion at the 30<sup>th</sup> meeting ranged from strong support for the direction that Metro Parks is taking to a sentiment for making no changes at all. The concept plan is reproduced below and can be found with photos of example facilities noted on the map. A better image is at the website: <http://www.metroparkstacoma.org/browns-point-lighthouse-park/>.

NETNC believes that the voters approved improvements at that park in the 2005 and 2014 capital bonds, and all taxpayers in the parks district are and will be paying for them. Some improvements are needed to broaden the access for users in the broad area. While it is too early in the planning process to list features to be developed, several items seem likely to end up in the recommended plan:

- Parking improvements, including provision for handicapped access vehicles and a drop-off area
- Historic and wayfinding signs
- Access improvements to pathways meeting ADA

- standards from the parking area to the cottage and the beach area
- Cleaning up and making safety improvements to the brushy area in the NE corner of the park
- Picnicking improvements
- Drainage improvements for the field area with a rain garden to absorb the runoff
- A telescope (save your quarters!) somewhere

The next steps include discussing the concept plan with stakeholders whose permission must be obtained to design and implement the improvement project: the Coast Guard, Pierce County planning and shoreline regulators, and U.S. and Pierce County landmarks commissions. The Puyallup Tribe, which sold the land to the Coast Guard in the early 20<sup>th</sup> century, will be consulted if possible. Later work includes estimating costs for likely improvements and testing them against the budget to develop a most feasible list. There will be further public discussion, as well.

## Planning for Improved Transit for NE Tacoma

NETNC is in discussion with Pierce Transit planners to eventually implement a re-designed transit service for our area. Pierce Transit has developed demonstration projects attuned to specific local needs for Gig Harbor (the Trolley), and the Fife-Milton-Edgewood area, and is prepared to do the same for NE Tacoma, if we can articulate our community's needs effectively.

First steps include asking for your input in a more-general NETNC survey for all households in NE Tacoma, followed up by a more-detailed survey from Pierce Transit.

We're very early in this process. Come find out more about it at the August 21<sup>st</sup> NETNC community meeting, 7pm, at the TPD NE Tacoma substation (corner of Northshore Parkway and Norpoint Way).

### CITY / SCHOOLS / PARK STAFF REPORTS:

**City Council** – Councilmember Thoms was away  
**City Manager's Office** – Julie Stoltman unavailable – forwarded material to announce

**Tacoma Fire Dept.:** Asst. Chief Pat McElligott spoke about fireworks (illegal in Tacoma) and how to take action. He reviewed the fact sheet that was also in the June NET News.

**Tacoma Police Dept.:** CLO Helen Stieben reviewed plans for Freedom Fair crowd control, . She advised that burglaries are taking place from garages with open doors, including loss of purses left in cars. House-breaking-burglaries are down, but noise complaints are up with more people with open windows in the good weather. She thought the June 7<sup>th</sup> Clean-Up Day went well, although the volume appeared down, and advised calling Call2Haul if

more stuff has accumulated before next year. Patrol shift supervisors have changed, and the day shift, which begins at 6am, starts with roll call at the Pine St. HQ – then NE officers come out here, so there is a break between the night shift (ending at 6am) and day shift coverage.

### PROGRAM:

**Community Assessment Project – Ideas for Community-Building:** Julia White, UWT social work

student. White reviewed results and conclusions from her study on neighborhood building focused on NE Tacoma.

- It was a challenge to get involved with the NE community, since she lives in Enumclaw.
  - She found scant places in NE Tacoma to “hang out”: golf course?, Center at Norpoint?, QFC?. More obvious places, such as the Hoyt Rd. Starbucks or the BP Diner, aren't in Tacoma.
  - She talked with Mayor Strickland, and had the impression that NE Tacoma is not high on her priority list.
  - She cited the history of development in the area, with difficulty of getting proper infrastructure. She cited our relative lack of success getting grants for sidewalks and bike lanes (although there are some notable successes).
  - Focusing on “means of community”, she recommended asset mapping, a concept espoused by Seattle-based community activist Jim Diers, who had addressed her class. Diers had shown an example of New Zealanders in a partly-destroyed city center (earthquake) took an empty space and made a bike-powered projector for showing movies – brings people together for an enjoyable experience.
  - She asked the group if people felt a sense of community, and a few participants responded positively. She thought the area is pretty “white-bread”, but there were comments about diversity.
  - White observed that community gardens are a good way to bring people together – everyone can be involved.
  - Participants brought up the community effort that got the bonds to build Norpoint, and the City-QFC deal that prevented another proposed supermarket from being established in the NW end of NE Tacoma.
- 2. BP Lighthouse Improvements Project:** Roger Stanton, project manager, MPT.  
Stanton described the Steering Committee and public meetings (two each) convened for input and reviews, and the original three concept plans produced. There is now a more-focused concept plan to review with the regulating stakeholders:

Elements most likely to be included are parking improvements, ADA-compliant pathways to the cottage and the beach, and dealing with the wetland in the field.

The next step is reviewing the concept with the various stakeholder regulators: U.S. Coast Guard, federal and Pierce County landmarks commissions, shoreline, Pierce County (building permits), and the Puyallup Tribe (if they are interested – they retain a residual interest in the property if it ever isn't used for a lighthouse). There are opinion conflicts between a number of long-time immediate area residents who want no or minimal change and the broader community that would like the park to be more useful. He reviewed some of the more difficult issues, and cited a best-case schedule that would have construction start next summer (not a Salmon Bake summer), but that is not certain.

**3. Norpoint Farmers Market:** Rose Ehl and Karla, Federal Way Farmers' Market. These NE Tacoma residents were invited by Phil Marr at the Center at Norpoint to establish a farmers market there. Ehl cited the difficulty of getting food vendors – permitting is expensive, and they need good crowds to justify the expense. The market will operate starting this coming weekend through the summer. There are lots of fresh food vendors (vegetables, fruit, berries) and some crafts, as well as food to eat there. The market seems to attract families who are headed for the Norpoint Park behind the Center.

#### COMMITTEE REPORTS:

- Communications Strategies: NET News – June issue distributed to local sites (~100: BP Town Center, "Walgreens strip", QFC strip businesses and NET convenience stores; library, Norpoint, substation), and by e-mail to ~300+ residents and ~28 officials and other contacts. E-mail list continuously cleaned up for non-working addresses.
- Need additional suggestions for website content

#### UNFINISHED BUSINESS:

- Patti Warwick confirmed as Board member, representing Area 2-Stonegate/Centennial. Still need representatives from NE Tacoma Area 1.
- NUSA learnings: Philp, Weed, Thurlow – deferred
- City crosswalks initiative: Thurlow described next steps
- Community Clean-up Day: no stats from the City, yet. Philp, Thurlow, and others related impressions.
- Fund for Community Projects grant finalization: A Fund for Community Projects grant was awarded by vote to Friends of Julia's Gulch for tools to replace those stolen last year (~\$1000).
- Progress review on 2014 goals – deferred (lack of time)

#### NEW BUSINESS:

- Thurlow reported that PSE is working with the Port on a proposed plant on the Blair-Hylebos peninsula to make liquefied natural gas (LNG) ships' fuel from pipeline natural gas. There will be follow-up at later NETNC meetings.
- A letter from the Co-chairs to the City Council asking for action on the proposed boundary change for NETNC to the middle of the Blair Waterway was approved. This boundary change will give NETNC "official" standing in dealing with developments on the Blair-Hylebos peninsula (the methanol plant discussed in May, and yet another LNG plant), as well as to better establish relationships with our upwind neighbors.
